OPTIONS FOR PAYING YOUR PROPERTY TAXES

Make checks payable to Rock Island County Collector.

Reference the 10-digit Property Index Number (PIN) on all checks, including your financial institution's online bill payment option. Your canceled check serves as your receipt.

If your mortgage company is to pay the bill, it may be indicated in the shaded area of each stub on this statement, or it is your responsibility to forward a copy to the mortgage company for payment.

The bill payment stub (perforated at the bottom of this page) must be included with payment by mail, at our office, or at a bank/credit union. Property owners will be charged \$2.00 for a duplicate bill. Mortgage companies will be charged \$5.00 memo bill fee per parcel/payment.

Installments equal to ¼ of the total tax bill are due on or before the dates shown on this statement. We do not accept partial payments. Taxes paid after November 27, 2023, must be paid by cashier's check, money order, or cash. An additional cost of \$10.00 is added on December 4, 2023, when delinquent notices are created to publish and mail.

Late payments - according to state law, a penalty of 1.5% per month, or portion of month thereof, will be charged on taxes not paid or postmarked by the due date, effective on the first day following each due date until paid or sold at Tax Sale. Penalty calculations are included on each stub.

Late payments must include interest penalty or your check will be returned.

There is a \$30.00 charge for all returned checks from your financial institution. Payment is void if check fails to clear and penalties continue to accrue until taxes are paid.

If you have sold this property, please forward this bill to the new owner or return to our office.

Billing address changes must be submitted in writing with an authorized signature. Billing Address Change Forms are available on our website and may be returned to the Treasurer's/Collector's Office in-person, by mail, email, or fax.

At your bank/credit union: See our website for a list of banks and credit unions that accept property tax payments on our behalf through November 7, 2023. Bring your entire bill with stubs. No Credit/Debit Cards

By mail: Send your check with the payment stub to the Rock Island County Collector, PO Box 3277, Rock Island, IL 61204-3277. Mailed payments must be postmarked on or before the due date to avoid penalty.

At our office: Pay in-person at the Rock Island County Office Building, 1504 3rd Avenue, Rock Island, IL 61201. We accept cash, check, cashier's check or money order, and credit/debit cards (processing fees up to 2.45% may apply) however no personal or business checks are accepted after November 27, 2023.

Drive-up Drop Box: Drop an envelope with your payment & stub inside the box located in the alley/parking lot behind the County Office Building.

Online: Pay using e-check, debit or credit card (processing fees apply) by going to our website www.rockislandcountyil.gov and clicking the "Pay Property Taxes Online" link. You can also enroll in automatic payments and email reminders. Sign up for paperless billing.

By phone: Dial 1-855-965-4400 and pay using e-check, debit or credit card (processing fees apply). Se habla español.
