

**STATEMENT OF INTEREST REQUEST FOR ENGINEERING SERVICES
ROCK ISLAND COUNTY
CH 50 & CH 55
Section No. 23-00400-00-BR**

Overview:

The Rock Island County Highway Department is in need of Phase I & Phase II engineering services, with an option for Phase III, for the replacement of existing PPC Deck Beams on structure 081-3094 located on CH 50 at the Rock Island/Whiteside county line and structure 081-3114 located on CH 55, approximately 1.75 miles east of US 67.

Structure 081-3094 – Single span, precast prestressed concrete deck beam bridge (52' - 4 ¼" BK to BK Abutments).

Structure 081-3114 – Three span, precast prestressed deck beam bridge (200' - 3 ½" BK to Bk Abutments).

Consultant Scope of Services:

Phase I & II preliminary engineering services are needed for all necessary work to prepare the plans, specifications and estimates (PS&E) package. Specific tasks include, but are not limited to:

- Data collection and survey
- Environmental studies coordination
- Prepare IDOT forms and reports, including the Bridge Condition Report and the Preliminary Bridge Design Hydraulic Report, if necessary.
- Prepare contract plans and project special provisions/specifications
- Prepare estimate of cost and time
- Right of Way acquisition including Highway Plats and Legals, if necessary

Phase I & II engineering are expected to be completed for a spring/summer 2024 Local letting.

Phase III, Construction Inspection, shall be included as an option.

Project Parameters:

- Preliminary Engineering will be funded with State MFT and County Local funds.
- The prime must be IDOT prequalified in the following categories:
 - Structures: Highway - Typical
- Construction will be funded with State MFT and County Local funds.
- The construction contract will be awarded by Rock Island County.

Statements of Interest (SOI) Requirements:

- SOI's shall be limited to not more than two (8 ½ X 11) pages and include, at a minimum, the following information:
 1. Name of firm with address and contact information
 2. Contact person for the firm

3. Statement indicating firm's interest in the project
4. Summary of projects similar in scope & magnitude recently completed by the firm
5. List of proposed key staff who would be assigned to the project
6. List of proposed sub consultants.

The selection of the Consultant will be made in compliance with the County's most current "Rock Island County Highway Department Qualification Based Selection Procedure – Non-Federal Participation" which is posted on the County's website, rockislandcounty.org

Shortlisted firms will be notified by mid/late September 2023. A statement of qualifications will be requested from each shortlisted firm.
