Guest speaker: Jill Cejka from Deafinitely Dogs! Service Dogs!

Deafinitely Dogs focuses on the human/dog relationship. The dogs are puppy raised from 6 to 8 weeks old. The dogs go through a thoroughly training, to provide assistance with multiple medical conditions to include PTSD, hearing loss, anxiety, and other disabilities. Jill is the community outreach liaison, and provides presentations about the organization.

The process for allowing a dog to pick their person increases their success rate. The national average for team rates (person/dog) matches is 65%, their retention rate is 100%. The dogs are puppy raised from 6 to 8 weeks, 13 dogs are annually assigned. Approximately 2 years of training for the puppies. Once the dogs are with their person for a few months, there is a graduation ceremony. Applying to receive a dog begins with a 17-page application, doctor records are reviewed and the process takes months not days. The dogs are trained to take care of the person, not trained as a support dog. They keep in touch with families after the dog has graduated the program.

Veterans are not charged for a dog, paid for through grants, donations, and sponsorships. A veteran cannot be homeless and has to be able to pay for vet cost, take care of self and dog. If veteran dies the dog is allowed to stay with the family. Deafinitely Dogs! Serve Dogs! is 1 of the 24 organizations that are part of the Wounded Warriors services. Average cost to train a service dog is \$28,000 to \$38,000. Program was approved to 2028, however funding may be affected due to current.
