**ORDER ON PETITION TO REVOKE OR MODIFY**

This cause comes before the Court for a hearing on a Petition to Revoke or Modify a prior sentencing order entered by the Court in this cause, the People of the State of Illinois appearing by the prosecuting authority, and the Defendant appearing personally (and by counsel), and the Court being duly advised in the premises, and

The Defendant having  admitted a violation of the Court's prior Order, as alleged in the Petition to Revoke or Modify;

OR

been found in violation of the Court's prior Order, as alleged in the Petition to Revoke or Modify;

**IT IS HEREBY ORDERED THAT:**

- (1) The Defendant's prior Order of Court Supervision is revoked, and conviction is entered.
- (2) The Defendant's prior Order of Conditional Discharge is revoked.
- (3) The Defendant's prior Order of Probation is revoked.
- (4) In addition to the revocation of the Court's prior sentence in this cause the Defendant is hereby resentenced as follows:
  - (a) The Defendant shall serve a term of:
    - (1) imprisonment in the Rock Island County Jail pursuant to an Order of Periodic Imprisonment entered this date and made a part of this Order.
    - (2) \_\_\_\_\_ days in the Rock Island County Jail, with credit for time served, said sentence to begin on \_\_\_\_\_, 20\_\_\_\_, at \_\_\_\_\_ .m.
  - (b) The Defendant shall pay an additional fine in the amount of \$ \_\_\_\_\_ .

(5) The Defendant's prior sentence is hereby modified as follows:

(a) The Defendant's prior sentence (court supervision, conditional discharge or probation, as ordered) is extended for a period of \_\_\_\_\_ months from \_\_\_\_\_. (Select either the date of the entry of this Order or the termination date of the original Order,)

(b) The Defendant shall serve a term of:

(1) imprisonment in the Rock Island County Jail subject to this Court's Order of Periodic Imprisonment entered this date and made a part of this Order. (No jail may be imposed under a supervision sentence.)

(2) \_\_\_\_\_ days in the Rock Island County Jail, with credit for time served, said sentence to begin on \_\_\_\_\_, 20 \_\_, at \_\_\_\_\_ .m.

(c) The Defendant shall pay an additional fine in the amount of \$ \_\_\_\_\_.

(d) The Defendant shall pay a court services fee in the amount of \$25.00 for each month his or her prior sentence has been extended, through the Circuit Clerk's Office according to the rules of Court Services.

(e) [SUPERVISION ONLY] The Defendant shall appear in Court on \_\_\_\_\_, 20, \_\_ at \_\_\_\_\_ .m., for a hearing to determine whether the Defendant has successfully complied with the terms and conditions of this extended supervision. If the court determines that the Defendant has successfully complied with the terms of this Order, the Court shall discharge the Defendant from supervision and enter an Order dismissing the charge.

(6) The Defendant shall pay the balance still owed on all fines, costs, and fees, and shall comply in full with all other terms and conditions of the Court's prior Order(s) which are not inconsistent with this Order.
